The California Hawking Club ("CHC") is a tax-exempt, nonprofit corporation founded in 1971 to insure the future and betterment of the fine art of Falconry. The CHC supports the preservation of all birds of prey through the active education of the public as an appropriate and effective conservation measure, and the dissemination of knowledge through research, meetings, reports, papers, discussions and publications. Membership in the CHC is open to all falconers and non-falconers.

CHC Membership consists of the following categories:

- General: California resident General or Master Falconer. May vote and hold CHC office.
- Apprentice: California resident Apprentice Falconer. May vote but may not hold CHC office.
- Affiliate: Non-resident Falconer, non-Falconer and all others. May not vote or hold CHC office.
- Family: Immediate family member of sponsoring General, Apprentice or Affiliate member. Family members do not independently receive CHC mailings, but receive the privileges of other categories for which they qualify.
